

<b>2.3 Instructions for use</b>	No IFU is required for this kind of product due to the low risk to user. All necessary information for safe use is available on labelling.

<b>2.5 Contraindications</b>	Do not use Leukoplast® Sleek on patients with known intolerance to latex or colophony.
